ADMINISTRATIVE ORDER

In light of the appointment of Nancy J. Rosenstengel as United States District Judge, the civil cases on the attached list will be reassigned from Chief Judge David R. Herndon, Judge Michael J. Reagan, Judge J. Phil Gilbert, and one case from Magistrate Judge Stephen C. Williams.

Rosenstengel will be entered in the East St. Louis criminal case assignment wheel for an equal share of all East St. Louis criminal cases.
