ADMINISTRATIVE ORDER

In light of the appointment of Staci M. Yandle as United States District Judge, the civil cases on the attached list will be reassigned from Chief Judge David R. Herndon, Judge Michael J. Reagan, Judge Nancy J. Rosenstengel, Judge J. Phil Gilbert, Magistrate Judge Philip Frazier, Magistrate Judge Donald G. Wilkerson, and Magistrate Judge Stephen C. Williams.

Yandle will be entered in the Benton criminal case assignment wheel for an equal share of all Benton criminal cases.
