**ADMINISTRATIVE ORDER**


Pursuant to 28 U.S.C. § 137, the East St. Louis criminal case assignment wheel is modified to include an equal share of cases for Chief Judge Michael J. Reagan, Judge David R. Herndon, Judge Nancy J. Rosenstengel, and Judge Staci M. Yandle.

The Benton criminal case assignment wheel is modified to include Judge J. Phil Gilbert for a full share of cases, and Judge Staci M. Yandle will receive a 25% share of cases.

A new criminal case assignment wheel will be created in East St. Louis to evenly distribute any criminal cases which have three or more defendants in the original indictment. Members of this wheel are Chief Judge Michael J. Reagan, Judge David R. Herndon, Judge Nancy J. Rosenstengel, and Judge Staci M. Yandle.

In order to equalize the pending criminal caseload, the cases on the attached list will be reassigned. Chief Judge Michael J. Reagan will receive seven of Judge David R. Herndon's cases (seven defendants). Judge Staci M. Yandle will receive 12 of Judge Nancy J. Rosenstengel's cases (22 defendants).
