

approximately equalized. During the criminal case equalization period, Judge Yandle and Senior Judge Gilbert will continue to be assigned new Benton criminal cases at a percentage of 50/50.

Judge McGlynn and Judge Dugan shall be added to the current civil and criminal nature of suit distribution sub-decks.

The following administrative orders regarding case assignments remain in effect:

- Administrative Order No. 257 regarding the inclusion of magistrate judges in the preliminary civil case distribution for purposes of soliciting consents under 28 U.S.C. § 636(c);
- Administrative Order No. 245 regarding habeas corpus cases; and
- Administrative order No. 223 regarding Social Security cases.
