ADMINISTRATIVE ORDER

To ensure the Court's docket is handled efficiently and expeditiously as the pandemic recedes, and in accordance with 28 U.S.C. § 137, the attached lists of randomly selected civil cases shall be reassigned as indicated in the listing. All deadlines and schedules previously set shall remain in effect unless and until reset by the transferee judge.

Within the CM/ECF system, new civil cases will be assigned randomly, but in ratios to equalize the dockets among the district's judges. When considering case referrals under 28 U.S.C. § 636(c)(1), the Court will be mindful of case equalization and efficiency.

Administrative Order No. 223 regarding the automatic referral by the Clerk of Social Security cases upon the consent of all parties pursuant to 28 U.S.C. § 636(c)(1) is hereby **RESCINDED**. Referrals will not be automatically processed; rather, the Clerk will act only upon direction of the Court.

The following administrative orders regarding case assignments remain in effect:

- Administrative Order No. 257 regarding the inclusion of magistrate judges in the preliminary civil case distribution for purposes of soliciting consents under 28 U.S.C. § 636(c); and
- Administrative Order No. 245 regarding habeas corpus cases.
