






Enter defendant's names, please do not create new parties. If you search for the defendant, all parties should already be in our system.

Docket the Complaint and pay the filing fee via pay.gov




Confirm that you are filing on behalf of the plaintiff and AGAINST the defendants. (next 2 screens)






The complaint will be attached as the main pdf. The civil cover sheet will be attached to the complaint as a separate pdf.
