Nature of Practice/Areas of Specialization: Mr. Diekemper worked for the NLRB at the Region 14 Office in St. Louis for one year as a field examiner and then field attorney. He then went into private practice in September 1972 representing unions and individuals for 34 years. He has been mediating cases since October 1993. He has mediated more than 1800 cases, with about two-thirds being labor/employment disputes. The remaining have been ERISA, legal and medical malpractice, personal injury, civil rights, business, and contract disputes. Some cases involved multiple plaintiffs and/or defendants. He has also arbitrated over 200 cases.

**Background**: Mr. Diekemper was born in Washington D.C. He came to St. Louis in 1952, growing up in Florissant, MO.

**Education**: Mr. Diekemper received his B.A. degree in Political Science from St. Louis University in 1968, and his J.D. degree from St. Louis University Law School in 1971. While at the Law School, he was a member of the Law

Journal. He is licensed to practice law in the state of Missouri and is admitted to practice in the Eastern District of Missouri federal court, the 8<sup>th</sup> Circuit and Federal Circuit Court of Appeals, and the U.S. Supreme Court.

Work History: Mr. Diekemper became a partner in the firm of Bartley, Goffstein, Bollato and Lange. He founded his own firm of Diekemper, Hammond and Shinners in 1979 where he tried civil lawsuits for both plaintiffs and defendants. He has also tried 250 arbitrations as an advocate.
